1 ACTIVITY ANALYSIS

SIF Muntenia is a legal Romanian person, established as a joint stock company with full privately owned capital. The operation of the company is regulated both by ordinary and special Romanian legislation, applicable to financial investment companies, and by its establishment deed.

SIF Muntenia was established as a joint stock company in November 1996 by restructuring and transformation of Muntenia IV Private Ownership Fund, pursuant to Law no. 133/1996 for the transformation of Private Ownership Funds into financial investments companies.

SIF Muntenia is a closed financial investment company with a diversified investment policy, which was established and is operating under its Constitutive Act.

Its main assets are financial instruments classified as such according to NSC / FSA regulations.

Through its mission statement SIF Muntenia has been structured as a "diversified balanced fund".

The overall objective of administration is to maintain SIF Muntenia as a diversified balanced fund, aiming to combine a balanced increase of the assets with moderate revenues, at a medium risk level.

Acquisitions and disposals of assets conducted by SIF Muntenia in the third quarter of 2016 relates to transactions of sale and purchase of securities. Details of these transactions are set out below in this Report.

1.1 ENVIRONMENT

The macroeconomic situation was favorable, we can mention a higher than expected pace achieved by the economic growth (in the second quarter of 2016 the GDP growth was 6% in annual terms), based on a broader increase in consumer demand, driven by higher household incomes. A proper conduct of economic policies in the near future, which will not be negatively influenced by populist measures in the period before the elections of November 2016 should lead to the preservation of macroeconomic balances while ensuring the sustainability of economic growth.

The inflation rate was maintained in the negative zone. The current short-term projection of NBR reconfirms the perspective of maintaining annual inflation in negative territory until December 2016.

Romanian banking system overcame the crisis period without major problems, the main aggregated indicators recording adequate solvency and liquidity levels or registering remarkable improvements to asset quality or profitability.

Both the interbank money market interest rates that are below the levels recorded in other countries in the region and the leu exchange rate tended to fall and maintain to levels slightly below those of the previous quarter.

Regarding the capital market, it can be mentioned that Romania was included in the list of countries with substantial potential to take the status of emerging market from the frontier market status by one of the major institutions internationally recognized (FTSE Russell). The criteria to be met mainly refers to the value of transactions and size of listed companies and investors' quick access to the capital market and how they can buy and sell shares.

BSE problems remain those that are already known, such as insufficient free float for listed companies with high growth potential and small trading volume (liquidity).

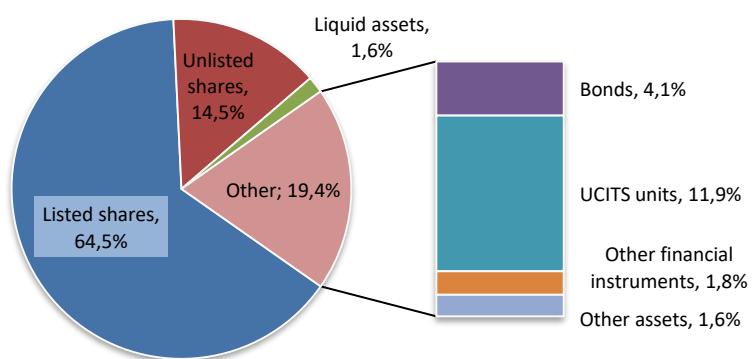

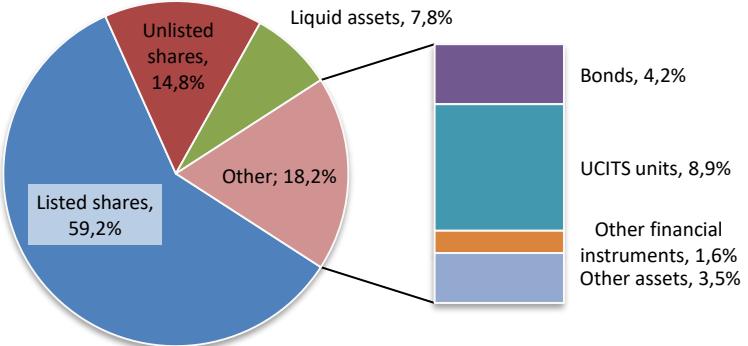

Asset allocation under sub-portfolios was within the limits of the investment programs approved by the shareholders according to the SIF Muntenia GSA, both in 2015 and 2016.

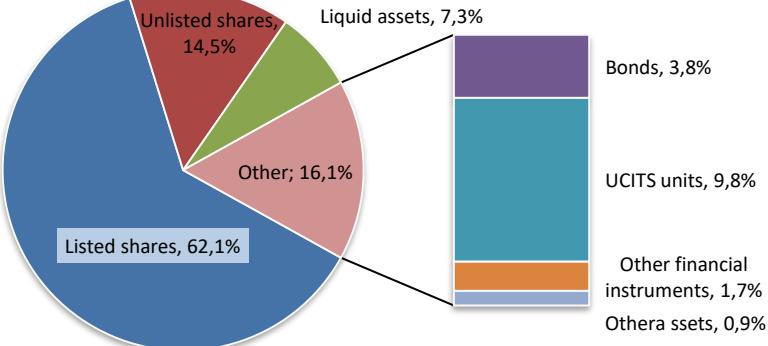
**30.09.2015

% of Total Assets**

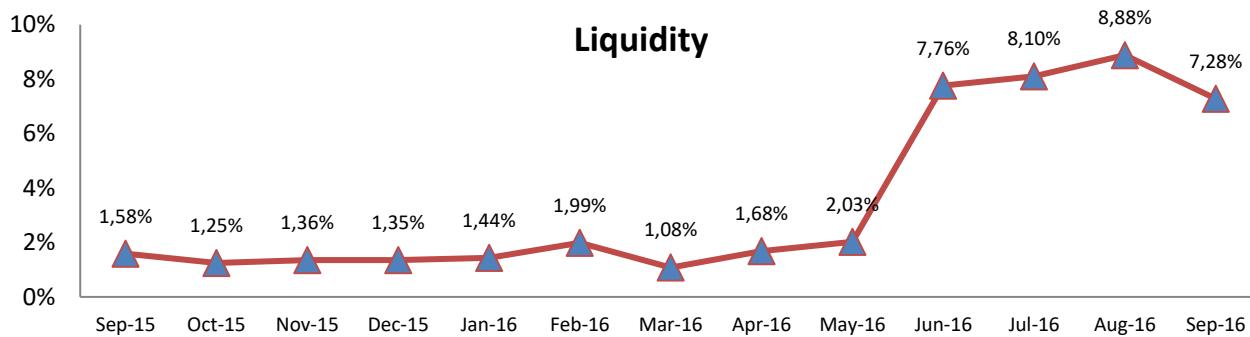

% of Total Assets**

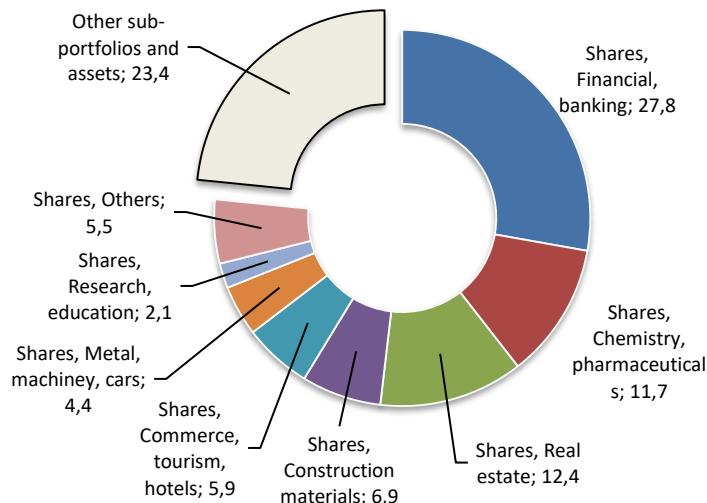


The main change in the portfolio in Q3 2016 is the percentage increase in value of listed shares sub-portfolio.

The liquidity of the portfolio, defined as the ratio of cash plus bank deposits and total assets was within the limits required by prudent management of liquidity risk and reflected the policy of reducing the amounts held in bank deposits amid their lower interest rates. The liquidity of the portfolio increased to a maximum of 8.88% at the end of August 2016. By an increased portfolio liquidity sources were provided for the payment of dividends to SIF Muntenia shareholders for the financial year 2015, procedure launched on 8 September 2016.



Shares in companies active in the banking sector further held the largest share in total assets of SIF Muntenia (details in Chapter Shares Sub-portfolio).



compared to 16,732,481 in the same period in 2015 (an increase of 250%).

Dividend income in 2016 from companies other than Banca Transilvania (which exceptionally granted dividend in cash, for the second time in the last 20 years and from where there were received net dividends of 31.05 million lei) have increased by 180% over the dividend income as of 30.09.2015.

Investment income came from sales of shares (details in Chapter Shares sub-portfolios) and had a lower value than in the corresponding period of 2015. Since SAI Muntenia Invest has not identified opportunities to a substantial profit, for a prudent management of the portfolio, only two larger transactions were made - one was attending a public offer to purchase shares made by SIF1 and at Globalworth Real Estate Investments, a company listed on the AIM segment of the London Stock Exchange, prudential reduction of exposure was continued due to BREXIT.

Interest income continued its decline, amid falling interest rates in Romania and declining during almost the entire last year of the degree of liquidity of the portfolio.

The main factor contributing to profit in the first nine months of 2016 were revenues from dividends – recorded a net dividend income of 58.5 mn lei (see chapter REB Execution).

Revenues from dividends on 30.09.2016 (which now, under IFRS, are recorded on a gross value, plus delay penalties) on the financial statements have amounted to 60.5 mn lei compared to 17.5 mn lei gross income from dividends in the financial statements according to IFRS as of 30.09. 2015.

Since the tax rate on dividends was different (generally 16% with some exceptions in 2015 and 5% in 2016), a meaningful comparison can be made only between net dividend income. As can be seen in the chapter Execution of revenues and expenses, net dividend income was 58,529,338 in the first nine months of 2016,

There were registered transactions with Bonds issued by OPUS Chartered Issuances, 1,140 financial instruments were sold at a price of 8.772 euro per financial instrument and 1,140 newly issued financial instruments were acquired at a price of 8.772 euros per financial instrument.

Warrants financial instruments issued by Merrill Lynch were maintained in the portfolio, through the sale of 28,000,000 mature warrants at a price of 0.7520 lei / warrant and 28,000,000 newly issued warrants were purchased at a price of 0.7708 lei / warrant.

1.3 TOTAL ASSETS AND NET ASSETS

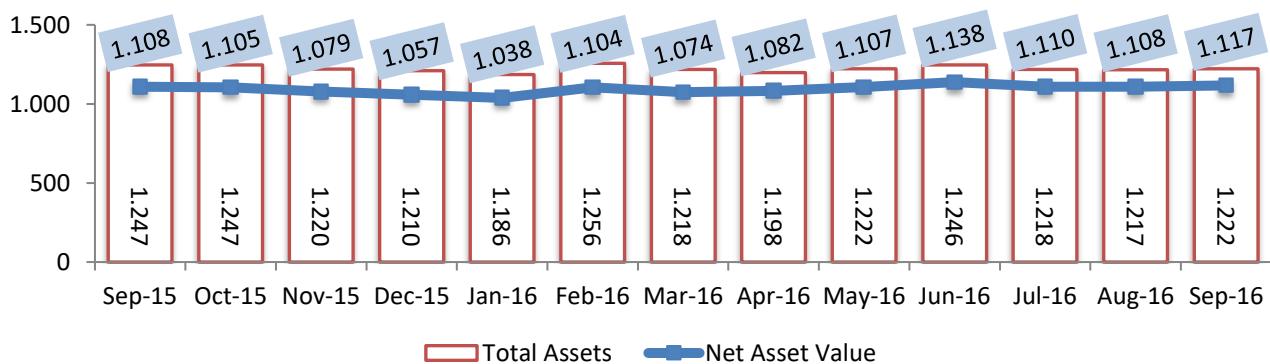
The net asset value (**NAV**) was calculated in accordance with Regulation no. 9/2014 issued by FSA and is then certified by the depository company of SIF Muntenia assets, Romanian Development Bank (BRD) - GSG.

Monthly Net Asset Values were published on the www.sifmuntenia.ro website in order to inform shareholders and reported in accordance with applicable regulations of the FSA - Instruments and Financial Services sector and the Bucharest Stock Exchange (BSE), no later than 15 calendar days since the reporting month.

Restated values of the total asset, net assets and liabilities related to 31.12.2015 are presented and used in this report, which also include accounting items related to the **final** financial statements for that period (IFRS financial statements / audited, Rule 39¹). The recalculated values were certified by the SIF Muntenia Depository.

The total asset values, liabilities and net assets for the period were calculated in accordance with Regulation no. 9/2014 issued by FSA, using accounting items related to the financial statements in accordance with IFRS.

Liabilities, which consist mostly of net dividends distributed tended almost continuously to decline during the period, both in value and as a share of total assets due to lower liabilities related to the dividends to be distributed to shareholders, especially after commencement the dividend distribution for the financial year 2015 in September 2016.

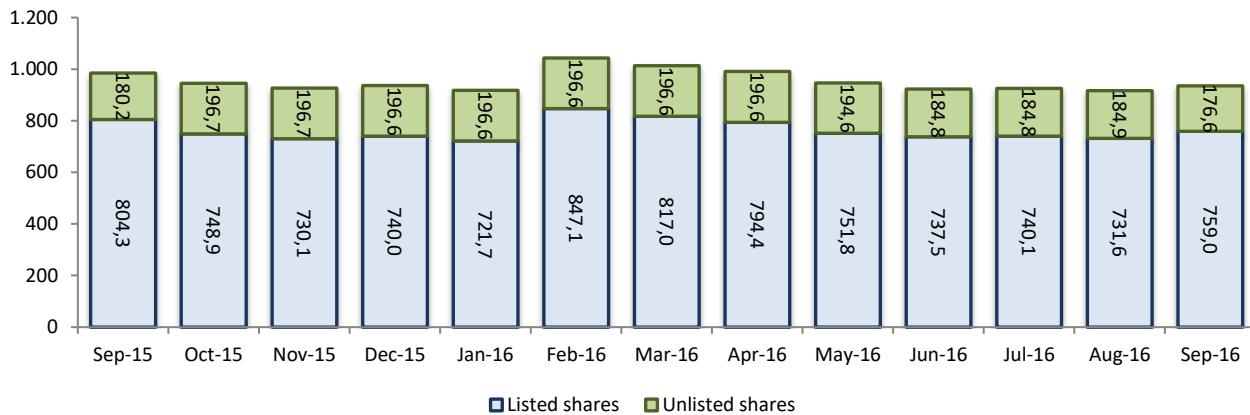

In Q3 2016 1,421,594 SIF Banat Crișana shares were sold (by attending the acquisition of shares public offer conducted by SIF Banat Crisana) and 48,700 Globalworth shares. In Q3 2016 no shares were purchased.

Observation

Following issues related to application of Law no. 151/2014 on the legal status of the shares traded on RASDAQ market or unlisted securities market, there are still registered uncollected amounts from a number of five companies, namely RON 7.11 million, amounts which are included under the portfolio item Other - assets, accounts receivable. SAI Muntenia Invest aims to collect these amounts through lawsuits or enforcements.

2.1 ALLOCATION ON SECTORS OF ACTIVITY

There were no significant changes in the weight of sectors, apparent decrease in the weight of companies with activities in retail banking at 30.06.2016 is due to the registration within the Other assets of the free shares issued by Banca Transilvania.

On 30.06.2016, bonus shares related to the capital increase by issuing new shares conducted by Banca Transilvania, numbering 16,887,120 and Teraplast SA Bistrita (582,553 shares) were not included in portfolios actions but in "Other assets" because the operation their allocation was completed July 2016.

Banca Transilvania (TLV) is a systemically important bank in Romania, whose activity is supervised by the National Bank of Romania.

Banca Transilvania shares are listed on the Bucharest Stock Exchange, the main market, premium category, TLV symbol.

Banca Transilvania is one of the three largest banks in Romania, in terms of assets, with a market share of 12.5%. Its activity is organized into three main business lines: Corporate, SME and Retail, respectively 3 sectoral approaches - agriculture, healthcare and European funds. BT has over 7,000 employees and a network of approximately 550 offices and 2.1 million active customers.

Banca Transilvania (TLV) recorded in H1 2016 net profit of 458.3 mill lei, 2.4 times higher than in the same period of the last year.

The solvency ratio of TLV, considering the profit registered under S1 2016 is 18.17% (without profit is 16.62%), close to the average Romanian banking sector.

Bad loans in arrears more than 90 days accounted for 9.17% of the total loan portfolio (financial sector average on 30 June 2016², according to the European Banking Authority's methodology, was 11.3%)

Banca Transilvania continued development as Financial Group style, focusing on subsidiary companies, which recorded a positive trend in their markets: investment banking, leasing, operating leasing, investment securities.

On 20 October 2016 Fitch Ratings confirmed the IDR rating for long-term financing of Banca Transilvania at 'BB' with a stable outlook, and the viability rating (VR) of BT at 'bb'. The potential of Banca Transilvania to generate increased revenue following the acquisition of Volksbank Romania and the exposure of Banca Transilvania on loans in Swiss francs taken from Volksbank Romania - the campaign of conversion already successfully deployed - was insignificant, accounting for only 3% of total loans at the end of the first semester of 2016.

Biofarm SA Bucharest (BIO) is one of the first Romanian medicines and dietary supplements producers, with a portfolio of over 200 products. With a tradition of over 90 years in the pharmaceutical industry in Romania, Biofarm is among the top 10 Romanian producers, achieving a market share of 3.80% of total units sold to patients on the Romanian pharmaceutical market, as reported by Cegedim Romania.

Biofarm is a strong market-oriented society, in the course of 2015 managing to develop 15 new formulations of medicines and dietary supplements.

Biofarm Bucuresti SA shares are listed on the Bucharest Stock Exchange, BIO symbol, the main segment, premium category.

On S1 2016 BIO recorded sales revenues of 69.2 million lei in the first half, down 1% compared to H1 / 2015 and the profit was 15.2 million, up 1% as compared to the same period last year.

The subscribed and paid share capital amounts to 80,703,651.5 lei, divided into 807,036,515 common shares with a par value of 0.1000 RON / share.

The main characteristics of SIF Muntenia shares

- All shares are ordinary shares, with a nominal value of 0.1 lei / share.
- There were no changes in the number of shares issued in Q1 2016. SIF Muntenia has not approved any repurchase program and has not made acquisitions of own shares.

SIF Muntenia has not issued bonds and / or other debt securities, having no liabilities of this type. Funding of the entire activity is achieved only through own funds.

Shares issued by SIF Muntenia are listed on the Bucharest Stock Exchange, the main market, the premium category, in accordance with the provisions of BSE Decision No. 200/1999 and are traded on the market since 01.11.1999.

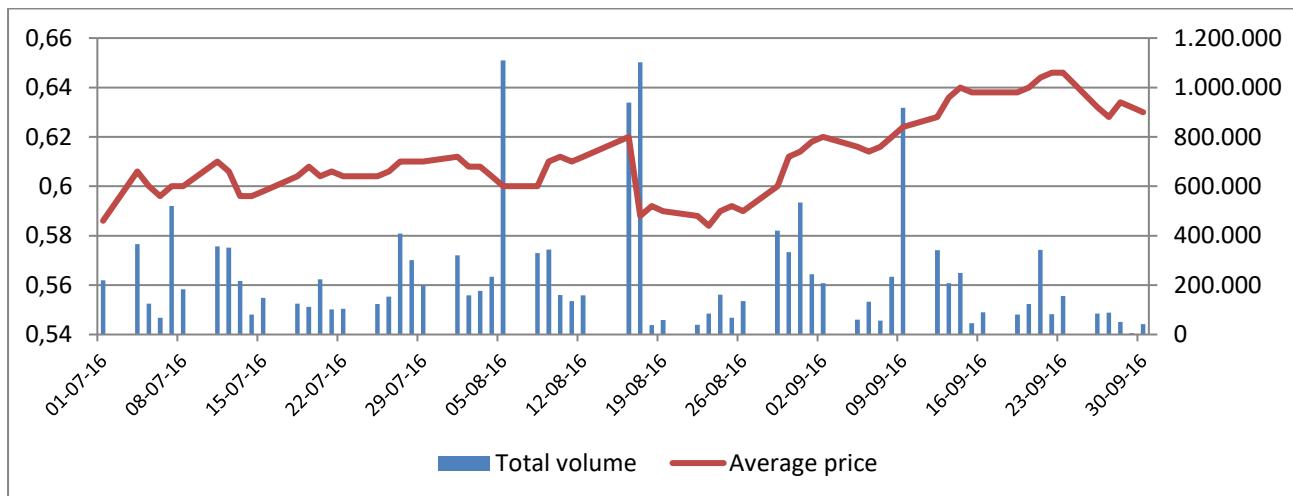
The registry of SIF Muntenia shares and shareholders are kept by the Central Depository S.A. Bucharest, a company authorized by the FSA.

3.2 DIVIDENDS

DIVIDEND POLICY

SIF Muntenia policy on the annual distribution of dividends or other benefits to shareholders was made in the process of voluntary compliance to the Corporate Governance Code of the Bucharest Stock Exchange applicable as of 4 January 2016 and presented to the SIF Muntenia website, Corporate Governance section.

"at general meetings of shareholders approving the financial statements, strategic programs of administration and budget of income and expenses, proposals for allocating the net profit will be presented and subject to shareholder approval, so as to maintain a balance between the remuneration to shareholders through dividend and necessary funds for the purchase of new financial instruments, to ensure increased value and quality of assets.

After completing numerous significant changes to the current legislative framework (IFRS and Alternative Investment Funds) SIF Muntenia will review the dividend policy and will inform shareholders in this regard."

The amount of dividends is approved by the General Meeting of Shareholders upon the proposal of the Board of Directors of SAI Muntenia Invest SA. Dividend tax is withheld and paid by SIF Muntenia, shareholders receive the net dividend minus distribution expenses.

The procedure for payment of dividends is presented on the website www.sifmuntenia.ro <http://sifmuntenia.ro/pdf/1859.pdf> and published on the BSE site by current report.

In the SGOM from 28 April 2016 by Decision no. 2, the distribution of a gross dividend was approved of RON 0.045 share for the financial year 2015 and by the Decision no. 3 the dividend distribution was approved with effect from 08.09.2016 which is considered the payment date, the shareholders bearing the costs of distribution.

In Q3 2016 net dividends were paid in the amount of 18 million lei, of which 17.8 million lei in September. Dividends payable to shareholders on 09.30.2016 amount to 84 million lei.

3.3 SHAREHOLDERS GENERAL MEETINGS

On 31.08.2016 the shareholders general meeting (SGM) of SIF Muntenia was held, for approving the consolidated financial statements of SIF Muntenia for the 2015 financial exercise. The SGM was convened and held according to law, the consolidated financial statements being approved.
