

The financial results (audited and nonconsolidated) of Impact Developer & Contractor (IMPACT) at 06.30.2008, calculated according to the International Accounting Standards (IFRS), show a gross profit of 23.6 mil. lei, which increased with 68% compared with the gross profit realized for the first 6 months of 2007.

The main indicators which reflect the IMPACT's financial results at 06.30.2008, calculated both according to Romanian Accounting Standards (OMFP 1752/2005), and according to the IFRS (audited, nonconsolidated), are the following:

It can be observed that the **Net Profit at 6 month** according to the OMFP **increased with 30%** compared with 2007, and according to the IFRS increased with 68% compared with the same period of 2007.

The increase in profit for the first half of 2008, is based on the production increase from 61.6 mil. lei in the first semester of 2007 to 102 mil. lei for the first 6 months of the year 2008.

It has to be mentioned the fact that this significant increase in production together with **the halfness of the IMPACT's gearing rate** from 68% at June 30th, 2007 to 33% at June 30th, 2008, assures an increased potential to attract other loans in order to develop new projects.

From the ongoing projects, in the first semester it was finalized the Europa project from Oradea, the first project of IMPACT that was realized in a partnership with the local authority.



Mentioning about the new projects,

- 1. In the first semester there were obtained all the permits needed for the approval of the Greenfield II project in Bucharest sector 1, and in August will be approved the building permit for the first semi-collective "cluster" building.
- 2. It was signed the contract for the new company Lomb SA, for the development of Lomb project, which is developed in partnership with the Local Municipality of Cluj-Napoca. In August, it will start the construction of the infrastructure for the Lomb's project.
