Nonetheless, the decision to select and appoint Mr.Healy was taken by the four current Board members that appointed him as interim member of the Fund's Board of Nominees on 13 February 2012.

Mr. Julian Healy has a broad investment experience in emerging markets with expertise in listed and unlisted equities portfolio management, as well as in various types of corporate accounting and financial industry. During 2006 - 2009, he has worked for the European Bank for Reconstruction and Development. Prior to that, he held various positions (including management) for JP Morgan Management (Jersey) Limited, JP Morgan Fleming Investment Management Limited, as well as for Morgan Grenfell & Co. Limited and Ernst & Young.

Currently, Mr. Julian Healy is an independent non-executive board director and member of the Institute of Chartered Accountants in England and Wales.

Mr. Healy has earned a British Council Postgraduate Scholarship at Charles University (Prague) and a bachelor's degree in Modern Languages at Cambridge University, Downing College (with First Class Honours). As at 13 February 2012, Mr. Healy held no shares issued by the Fund.
