Important events to be reported: Information regarding litigation in which the Company is involved:
The Company hereby informs the shareholders and investors with regard to the ruling issued on 21.05.2019 in File No. 28565/3/2017, registered on the dockets of the Bucharest Tribunal, VI Civil Section.

The file has as its parties Impact, as plaintiff, and Stegaru Ruxandra-Maria and Tal Joshua Moses Almong, as defendants.

The object of the litigation is to compel the defendants to pay RON 3,710,386, representing the prejudice suffered by Impact further to the non-compliance by the defendants with the guarantee against eviction derived from the Social Parts Sale-Purchase Agreement concluded on 05.07.2006.

The court issued the following ruling on 21.05.2019: The court admits the lack of interest invoked by defendant Stegaru Ruxandra-Maria. It rejects the head of claim against defendant Stegaru Ruxandra-Maria as lacking interest. It rejects the head of claim against defendant Tal Joshua Moses Almong as ungrounded. Subject to appeal within 30 days from its communication.

Impact will continue legal steps.
