1. TMK-ARTROM S.A. (the "Seller") reports the conclusion of addendum no.8 dated 06.01.2020 to the sale purchase contract no.990 dated 30.12.2011 (the "Contract") with TMK-RESITA (the "Buyer"), a Romanian company, based in Resita, Romania, company that is under the sole control of TMK-ARTROM S.A (the Seller and the Buyer together the "Parties"), having as object the establishment of the value of the Contract for 2020, respectively approximative 26.000.000 euro, as well as the extension of its validity until 31.12.2020.

2. TMK-ARTROM S.A. (the "Seller") reports the conclusion of an addendum dated 07.01.2020 to the sale-purchase contract no. 12 dated 08.01.2019 (the "Contract") with TMK-RESITA S.A. (the "Buyer"), a Romanian company, based in Resita, Romania, controlled by TMK-ARTROM S.A. (the Seller and the Buyer together the "Parties"), having as object the establishment of the value of the Contract for 2020, respectively approximative 42,000,000 lei, as well as the extension of its validity until 31.12.2020.
