S.I.F. Oltenia S.A. informs investors that in the file no.2635/63/2020 before Craiova Court of Appeal against S.I.F. Muntenia S.A., SAI CERTINVEST S.A., FIA CERTINVEST ACTIUNI, FDI CERTINVEST BET FI INDEX, FDI CERTINVEST XT INDEX, S.I.F. BANAT-CRIŞANA S.A. as plaintiffs, ASOCIAȚIA INVESTITORILOR PE PIAȚA DE CAPITAL as appeal plaintiff, UNGUREANU LIVIU, TUDOR DUMITRU, FORTAN PROCOPIE, RĂDUT DUMITRU as intervener defendants, having as object judge's order, namely suspension of execution of the Decisions no. 1-8 of the S.I.F. Oltenia S.A.Ordinary General Shareholder Meeting on 28.04.2020 chaired by Board of Administration Chairman Mr. Tudor Ciurezu, until settlement of the claim formulated by S.I.F. Muntenia S.A. regarding establishment of the absolute nulity of the S.I.F Oltenia S.A. OGSM on 28.04.2020 by definitive judgement and recording with Trade Office Register of the entry for susupension of execution of the Decisions no. 1-8 of the S.I.F. Oltenia S.A.Ordinary General Shareholder Meeting on 28.04.2020 chaired by Board of Administration Chairman Mr. Tudor Ciurezu, the court rejects the exception of the appeal formulated by S.I.F. MUNTENIA S.A. It admits the appeals. It changes entirely the sentence in the sense that it admits the requests of the plaintiffs. It suspends the execution of the Decisions no.1-8 adopted by S.I.F. Oltenia S.A. OGSM on 28.04.2020 chaired by the Board of Administration Chairman until definitive settlement of the requests having as object establishment of the respective decisions nulity. It admits the request of ancillary intervention in interest of the plaintiffs SAI CERTINVEST S.A., FIA CERTINVEST ACȚIUNI, FDI CERTINVEST BET FI INDEX si FDI CERTINVEST XT INDEX, formulated by the interveners Asociatia Investitorilor pe Piata de Capital. It rejects the request of intervention in interest of the defendant formulated by the interveners Ungureanu Liviu, Tudor Dumitru, Forțan Procopie și Răduț Dumitru. The decision is definitive.
