S.I.F. Oltenia S.A. informs shareholders and investors that on 27.08.2020 the ASF Authorization no. 155/26.08.2020 has been communicated having as object changing of art.8 par (3) of the SIF Oltenia Articles of association, as it was approved by Decision no.4 of EGSM on 09.05.2019.

In this context, the Board of Administration will immediately call the general meeting corresponding to the new Articles of association for election of a Board of Administration of 5 members, after registering with the National Trade Office of the changes authorised with compliance of all legal provisions.

Against this backdrop, we consider that the requests for calling an OGSM formulated by the shareholders S.I.F. Banat - Crişana S.A. and S.I.F. Muntenia S.A. on 11.06.2020 and 28.07.2020 no longer meet the new constitutive act.
