DECISIONS OF THE INDEX COMMITTEE IN THE MEETING OF MARCH 3

The weights of the indices' components, i.e. the free-float factors (FF), the representation factors (FR), the liquidity factors (FL) and the price correction factors (FCi), will be determined based on the number of shares and closing prices registered at the end of the trading session of **March 13, 2020**.

The new structures of BVB indices will be announced at the end of **March 13, 2020**, and will become effective as of **March 23, 2020**.
