IMPETUM INVESTMENTS S.A. (the "Company") informs investors regarding **the payment of coupon no. 8** related to the corporate bonds issued by the Company on 20.06.2024 and traded on the Multilateral Trading System – administered by the BSE under the symbol IMPI26E, which will be made on the payment date of **31 March 2026**, in accordance with the provisions of the Listing Memorandum.

The payment of coupon no. 8, with **a gross value of EUR 22.6849 per bond**, as well as the principal, will be carried out through Depozitarul Central S.A. to the bondholders registered on **the reference date of 17 March 2026** in the Bondholders' Register kept by Depozitarul Central S.A.

The payment of the amounts due will be made by bank transfer to the accounts of the Participants in the system of Depozitarul Central.

**IMPETUM INVESTMENTS S.A. collects tax residency certificates until 19 March 2026.** Non-resident individuals who do not submit a tax residency certificate will have withholding tax applied at source on the amount due, in accordance with the applicable provisions of the Romanian Fiscal Code, Article 224 paragraph (4).

According to the provisions of the Listing Memorandum, the value of the coupon for the period of 91 days, from 31.12.2025 until 31.03.2026, is calculated at a fixed annual interest rate of 9%.
