Important events to be reported - Fondul Proprietatea SA (the “Fund”): Update on all litigations between a Litigant shareholder and the Fund

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch (“FTIML Bucharest Branch / The Fund Manager”), in its capacity as Sole Administrator and Fund Manager of the Fund, would like to update shareholders on all cases between Ioana Sfiraiala (the “Litigant”) and the Fund, as set out in the table attached as an Annex to this report.

The Fund Manager would like to inform investors and shareholders that in file 42956/3/2012 the final hearing took place on 5 December 2012 and the court ruled in favour of the Fund, rejecting the request filed by the Litigant asking for the suspension of EGM Resolution no. 5/29 Nov. 2010 and of EGM Resolution no. 1/23 Nov. 2011, both for approving the Fund’s Constitutive Act.
