Important events to be reported - Fondul Proprietatea SA (the “Fund”): Update on all litigations between a Litigant shareholder and the Fund

Franklin Templeton Investment Management Ltd. United Kingdom Bucharest Branch (“FTIML Bucharest Branch / The Fund Manager”), in its capacity as Sole Administrator and Fund Manager of the Fund, would like to update shareholders on all cases between Ioana Sfiraiala (the “Litigant”) and the Fund, as set out in the table attached as an Annex to this report.

I. The Fund Manager would like to inform investors and shareholders that, on 12 December 2012, the Bucharest Court of Appeal announced that it ruled in favor of the Fund in file no.26255/3/2012 and rejected the appeal of the Litigant.

The Fund Manager reminds the Fund’s shareholders that, in file no. 26255/3/2012, the Litigant requested the Bucharest Court to block the registration with the Trade Register of Ordinary General Shareholders Meeting (OGM) Resolution no. 20/2012 for approving the second Addendum to the 2012 Budget and on 12 October 2012 the Bucharest Court ruled in favour of the Fund and decided to:

- Reject the request of intervention of the Litigant;
- Admit the request of the Fund and order the Trade Register to register the OGM Resolution no. 20/2012 for approving the second Addendum to the 2012 Budget.

The decision issued by the Bucharest Court of Appeal is irrevocable.

II. The Fund Manager would like to inform investors and shareholders that in file 15961/3/2012 the Bucharest Court ruled in favour of the Fund and decided to:

- Admit the request of intervention filed by Manchester Securities;
- Reject the objection raised by the Litigant claiming that FTIML Bucharest Branch cannot represent the Fund;
- Reject the request of intervention of the Litigant;
- Admit the request of the Fund and order the Trade Register to register the OGM Resolution no. 16 of 25 April 2012 for the adoption of the Investment Management Agreement, OGM Resolution no. 17 of 25 April 2012 for the ratification of all the legal acts concluded by FTIM Bucharest Branch as Sole Administrator of Fondul Proprietatea S.A. during 6 September 2010 - 24 April 2012, and OGM Resolution

no. 18 of 25 April 2012 for the adoption of all the legal acts concluded by FTIML Bucharest Branch as Sole Administrator of Fondul Proprietatea S.A. during 6 September 2010 - 24 April 2012;

- Oblige the Litigant to pay the amount of **RON 58,177.64** to the Fund as legal fees.
The decision issued by the Bucharest Court can be appealed.

III. The Fund Manager would like to inform investors and shareholders that in file 26253/3/2012 the Bucharest Court ruled in favour of the Fund and decided to:

- Reject the objection raised by the Litigant claiming that FTIML Bucharest Branch cannot represent the Fund;
- Reject the request of intervention of the Litigant;
- Admit the request of the Fund and order the Trade Register to register the OGM Resolution no. 22/2012 approved on 27 June 2012 - the approval for hiring independent evaluators for NAV calculation;
- Oblige the Litigant to pay the amount of **RON 29,509.39** to the Fund as legal fees.

The decision issued by the Bucharest Court can be appealed.

Please also note that the table below has been updated with details of two new cases, namely file no. 47387/3/2012 and 48024/3/2012, and the latest news on the ongoing cases.

The Fund Manager will continue to update shareholders and investors of any further material developments in these files, and will continue to vigorously defend the interests of the Fund and all its shareholders.
