**Important event to be reported: Report on file no.5119/118/2017, in contradictory with ANAF**

OIL TERMINAL SA informs the shareholders and investors on the fact that, by civil sentence of 17.12.2018, the appeal court, namely Constanta Court of Appeal gave the following solution in file no.5119/118/2017:

- *‘It admits D.G.R.F.P. Galati’ appeal through A.J.F.P.Constanta, it changes partly the appealed sentence, rejecting the action in contradictory with A.N.V through Constanta General Direction for Excises and Customs Operations as being given to a competent person*
- *It obliges Galati D.D.R.F.P. to pay 89,445 lei VAT included as court costs in file no.25976/212/2011, to the claimant.*
- *It rejects the other claims as groundless.*
- *It maintains the appealed sentence orders regarding the exception of the material right’ sanction to action in term.*
- *It rejects the present appeal as groundless’.*

The decision is not final, it can be appealed in 30 days since communication.

The civil sentence is going to be edited and communicated to parties.

We mention that the data are taken from the courts web sites.

We remind that, on 31.07.2017, Oil Terminal SA submitted an action in contradictory with Galati – Regional Direction of Public Finances – Constanta Oublic Finances Administration – Customs National Authority through Constanta Direction for excises and Customs operations, by which it requested to Constanta Court of Justice to give a decision by which the defendant id obliged to pay the court costs in a total of 241,661.53 lei, representing court costs of Oil Terminal SA in file no.25976/212/2011 for first instance and appeal stages, as follows:

- 233,981.53 lei barrister fee,
- 7,680 lei expert fee,

- 4,043 lei – judicial fee in file no. 5119/118/2017.

The request was the object of File no. 5119/118/2017, pending on Constanta Court of Justice.

By civil sentence no.2592/29.11.2017, the first instance, namely Constanta Court of Justice gave the following solution:

- *‘It rejects the exception of the material right’ sanction to action in term, invoked ny the defendant, as groundless*
- *It partly admits the summons submitted by Oil Terminal SA Constanta.*
- *It obliges the defendants to pay the total amount of 130,328.50 lei as court costs in civil file no.5119/118/2017’.*
