At the end of 2022, Antibiotice inaugurated the most modern plant in Europe for topical medicines, 20 million euro investment, thus consolidating its position as a national leader in the manufacture of pharmaceutical topical products. With a capacity higher by 50% than the old one and meeting the highest production and quality standards, this investment offers our company a greater openness to international markets which are characterized by a high degree of competitiveness and innovation.

In May 2023, Antibiotice obtained also the approval for non-reimbursable funds amounting to over 85 million lei for a manufacturing capacity for sterile products, solutions and topicals.

The new production capacities along with 100 new products attracted in the portfolio up to the horizon of 2030, are an integral part of the company's strategic development plan "The Future Together" which aims at doubling the turnover, profit and increasing the market shares both domestically and internationally.

Therefore, our 20-year continuous presence at CPHI Worldwide represents a premise for expanding and consolidating our business in foreign markets alongside our partners, Antibiotice being the most important Romanian manufacturer of generic medicines with international recognition, exporting in 70 countries worldwide.
