Please find attached the EVERGENT Investments Assets and Liabilities Statement as of May 2026, in compliance with FSA Regulation no. 9/2014 and no. 7/2020 - Annex 10 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main monthly relevant evolutions by asset categories (in RON):

- listed shares: + 145.7 million
- AIF listed shares: + 0.7 million
- fund units: + 35.2 million
- monetary instruments: + 5.0 million

The main asset classes in the total value of the assets under management: listed shares including the AIF listed shares 67.0%, unlisted shares 8.7%, fund units 11.8%, monetary instruments 10.0%.

The net result, amounting to RON 321.80 million, consists of RON 162.26 million net profit and RON 159.54 million net gain on the sale of financial assets reflected in retained earnings - accounting treatment in accordance with IFRS 9.
