

Decision no. 239/03.03.2026), it purchased 32,003,317 own shares representing 8.2060% of the share capital.

Thus, at the present time, the Company owns a number of 32,003,317 own shares representing 8.2060% of the share capital.

During the period of their holding by the Company, the 32,003,317 shares do not give the right to a dividend and have suspended voting rights.



The persons acting in concert with the Company own shares issued by Infinity Capital Investments S.A. like this:


- Mr. Sorin Iulian Cioacă - President - General Manager owns 1,275,000 INFINITY shares;

Thus, Infinity Capital Investments S.A., together with the persons acting in concert, directly and indirectly holds 35,154,611 shares, representing 9.014% of the Company's share capital.
