- 1,002 shares, representing 6.7034% of the subscribed and paid-in share capital of FORTALIS HOLDING, headquartered in Bucharest, 89-97 Grigore Alexandrescu Street, Sector 1, Romania, registered with the Trade Registry under no. J2017015602402, with CUI RO38201915. The total value of the transaction is approximately 4,320,000 euros in RON equivalent.
- 460 shares, representing 3.0500% of the subscribed and paid-in share capital of FORTALIS HOLDING, headquartered in Bucharest, 89-97 Grigore Alexandrescu Street, Sector 1, Romania, registered with the Trade Registry under no. J2017015602402, with CUI RO38201915. The total value of the transaction is approximately 2,040,000 euros in RON equivalent.

Thus, following these acquisitions, Prebet Aiud SA holds a total of 33.3709% of the capital of FORTALIS HOLDING (formerly Societatea De Investitii Alternative Cu Capital Privat Roca Investments S.A.)
