IMPORTANT EVENT TO REPORT: Dissolution of Chimprod SA

Sinteza SA informs shareholders and investors that, with regard to Chimprod SA, on 04.06.2026 the court in File no. 3320/111/2025 pending before the Bihor Court, by interim decision, admitted the request made by the judicial administrator CII NISTOR MATILDA and pursuant to art. 145 para. 1 point B of Law no. 85/2014 on insolvency prevention and insolvency procedures, orders the commencement of the general bankruptcy procedure of the debtor Chimprod SA. At the same time, pursuant to art. 145 para. 2 letter b of Law no. 85/2014, it appoints CII NISTOR MATILDA as provisional judicial liquidator who will fulfill the duties provided for in art. 58 of the insolvency law and orders the dissolution of the debtor company and the lifting of the debtor's right of administration. The decision is enforceable, with the right of appeal within 7 days from the communication made by publication in the Insolvency Proceedings Bulletin.

The company Chimprod SA has had its activity suspended for more than 6 years, the company's shares are not traded on the regulated securities market, for the financial year 2025, the parent company SINTEZA SA has prepared consolidated financial statements, the consolidation includes the company Chimprod SA, the stake held by Sinteza S.A. is 99.765%.
