DECISIONS OF THE INDEX COMMITTEE IN THE MEETING OF SEPTEMBER 9

[Bucharest Stock Exchange \(BVB\)](#) informs that on the 9th of September 2020, the quarterly meeting of the BVB Index Committee ("CI") took place. BVB Index Committee decided the following:

1. To maintain unchanged the composition of BET and BET-TR indices.
2. To change the composition of BET-XT and BET-XT-TR, as follows:
 - 2.1 include BITTNET SA (symbol BNET, ISIN ROBNETACNOR1) and TURBOMECANICA SA (symbol TBM, ISIN ROTBMBACNOR9)
 - 2.2 exclude ANTIBIOTICE SA (symbol ATB, ISIN ROATBIACNOR9) and COMPA SA (symbol CMP, ISIN ROCMPSACNOR9)
 - 2.3 update the Watchlist, by removing TURBOMECANICA SA.
3. To change the composition of BET-BK, as follows:
 - 3.1 include BITTNET SA (symbol BNET, ISIN ROBNETACNOR1)
 - 3.2 exclude COMPA SA (symbol CMP, ISIN ROCMPSACNOR9)
 - 3.3 update the Watchlist, by including ANTIBIOTICE SA and removing OIL TERMINAL SA.
4. To change the composition of BET-Plus, as follows:
 - 4.1 include BITTNET SA (symbol BNET, ISIN ROBNETACNOR1), ROMPETROL WELL SERVICES SA (symbol PTR, ISIN ROPESAACNOR0), ALUMIL ROM INDUSTRY SA (symbol ALU, ISIN ROALUMACNOR8),

4.2 exclude SOCEP SA (symbol SOCP, ISIN ROSOCPACNOR5) and ALTUR SA (symbol ALT, ISIN ROALTCACNOR1).

5. To maintain unchanged the composition of BET-NG and BET-FI indices.

The weights of the indices' components, i.e. the free-float factors (FF), the representation factors (FR), the liquidity factors (FL) and the price correction factors (FCi), will be determined based on the number of shares and closing prices registered at the end of the trading session of **September 11, 2020**.

The new structures of BVB indices will be announced at the end of **September 11, 2020**, and will become effective as of **September 21, 2020**.
